ORDER.

In pursuance of the decisions of the National Implementation Committee for Administrative Re-organisation (NICAR) and on the recommendations of the Sub-Committee headed by the Cabinet Secretary which were approved by the High Powerd National Implementation Committee for Land Reforms headed by the Minister-in-charge of the Ministry of Agriculture, Government have been pleased to approve the the following re-organised set-up of the Revenue Administration:-

Re-organised Revenue set-up under the administrative control of the Ministry of Land Administration & Land Reforms.

(i) There will be one Tahsil Office in each Union. The expansion programme will be phased over three years, one-third in each year. Each Tahsil Office will have the following staff members:-

(c) In addition, the following staff will be posted to the Upazilas which are not covered by the Survey and Settlement set-up. These additional staff will be merged with the Settlement set-up later on.

(d) Provision of additional staff viz 2 Guards (NNS Tk. 225-315/-) and 1 Sweeper (NNS Tk. 225-315/-) will also be made for those offices which would be located out side the Upazila complexes.

(e) All the Upazilas of the Country will be covered by the above mentioned scheme over a period of 5 years (20% in each year).

(f) There will be 22 Zonal Survey and Settlement Offices throughout the Country covering the existing districts. As Settlement operation is going on in districts these will be allowed to continue in their present form now. The new set-up will be introduced in the zones (existing districts) @ 4 districts per year for the first three years and thereafter @ 5 districts per year for the last two years covering a total of 5 (five) years. Districts where revisional operation has been completed after 1972 or are under revisional operation now will be brought under the new scheme last of all. Each Zonal Survey and Settlement Officer will have the following 28 personnel:-

- (vii) The Management set-up at the District level will remain unchanged. The Deputy Commissioner will continue to be Collector also. In all the districts the A.D.C. (Rev.) should look after the revenue functions under the control of the Deputy Commissioners. The ACR of the ADC (Rev.) is to be written by the concerned Deputy Commissioner and countersigned by the Chairman, Board of Land Administration.
- (viii) The Ministry of Establishment will directly post officers as ADC (Rev.) in consultation with the Ministry of Land Administration And Land Reform. An Officer should work for 2 to 3 years when assigned to revenue work unless his withdrawal is asked for by the Ministry of L.A.
